

TARGETING – Part Three: DEFINITION of a TARGETED INDIVIDUAL, TI, NON LETHAL WEAPONS

Top Definition for Targeted individual

A Targeted individual is a person who has been singled out by a criminal syndicate called “Organized Gang Stalking”. The targeted individual is under 24 hour surveillance and is stalked by large groups of various criminals. The new technologies have brought about the possibility of this crime. All of the wireless devices can be hacked and tracked. The criminals carry non lethal weapons in their cars and use them against the Targeted Individual. The weapons are both easy to buy or easy to make. They use lasers, dazzlers, hand held microwave, x ray devices, plasma beams, and other directed energy weapons. These people that are willing to go around and torment, torture and even murder people are getting a pay off. And if they are being threatened and are doing it out of fear then this next verse applies to them:

Luke 12:4-5 – (Jesus speaking) And I say unto you my friends, Be not afraid of them that kill the body, and after that have no more that they can do. But I will forewarn you whom ye shall fear: Fear Him, which after He hath killed hath power to cast into hell; yea, I say unto you, Fear Him.

There are now so many victims that the crime is no longer being denied. Even the Department of Justice has verified the fact that group stalking is on a significant rise with a government survey. A 2009 DOJ study verified there were a total 3,398,630 reported victims of stalking. Out of the total number of stalking victims 13.1% documented that they had at least 3 or more stalkers. A quick average of the figures (441,821 victims had 3 or more stalkers) (200,000 victims had more stalkers than they could count).

2nd Definition of a Targeted Individual

A person with paranoid schizophrenia who thinks the government and/or CIA and/or illuminati and/or lizard people are torturing them with energy pulse and radar weapons. NON LETHAL WEAPONS

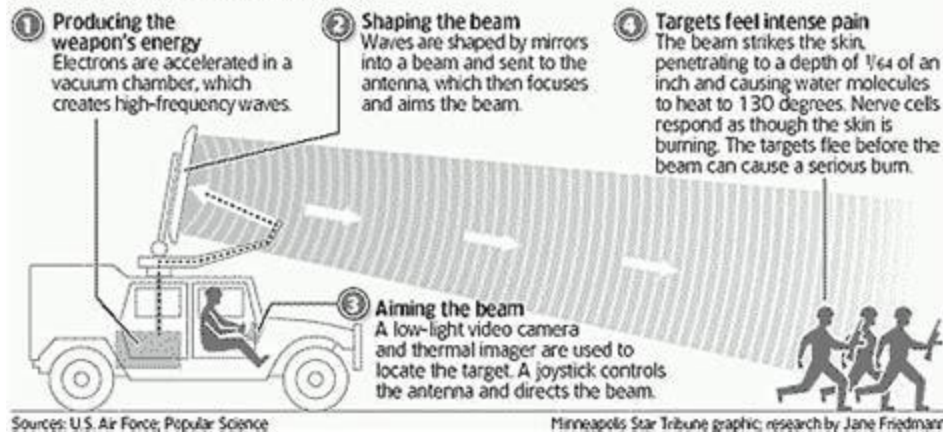


The US-Israeli Tactical High Energy weapon has been used to shoot down rockets and artillery shells.

Many types of laser can potentially be used as incapacitating weapons, through their ability to produce temporary or permanent vision loss when aimed at the eyes. The degree, character, and duration of vision impairment caused by eye exposure to laser light varies with the power of the laser, the wavelength(s), the collimation of the beam, the exact orientation of the beam, and the duration of exposure. Lasers of even a fraction of a watt in power can produce immediate, permanent vision loss under certain conditions, making such lasers potential non-lethal but incapacitating weapons. The extreme handicap that laser-induced blindness represents makes the use of lasers even as non-lethal weapons morally controversial, and weapons designed to cause permanent blindness have been banned by the Protocol on Blinding Laser Weapons. Weapons designed to cause temporary blindness, known as dazzlers, are used by military and sometimes law enforcement organizations. Incidents of pilots being exposed to lasers while flying have prompted aviation authorities to implement special procedures to deal with such hazards.

A new weapon: Intolerable pain, little damage

The "Active Denial System" uses a beam of energy to produce an overwhelming burning sensation on the skin without causing serious burns. The weapon could be used to repel enemy troops, disperse hostile crowds, suppress sniper activity or create a defensive barrier.



This is called ADS (active denial system)

In 2004, author Jon Ronson cited an unclassified military report titled "Non-Lethal Weapons: Terms and References" 21 acoustic weapons were listed, in various stages of development, including the Infrasound ("Very low-frequency sound which can travel long distances and easily penetrate most buildings and vehicles ... biophysical effects are projected to be: **nausea, loss of bowels, disorientation, vomiting, potential internal organ damage or death may occur.** Superior to ultrasound...)", however no such effects had been achieved as of 2002.

Non-lethal weapons are intended to minimize injury or death.

SO THESE WEAPONS ARE BEING USED IN A LETHAL WAY.*

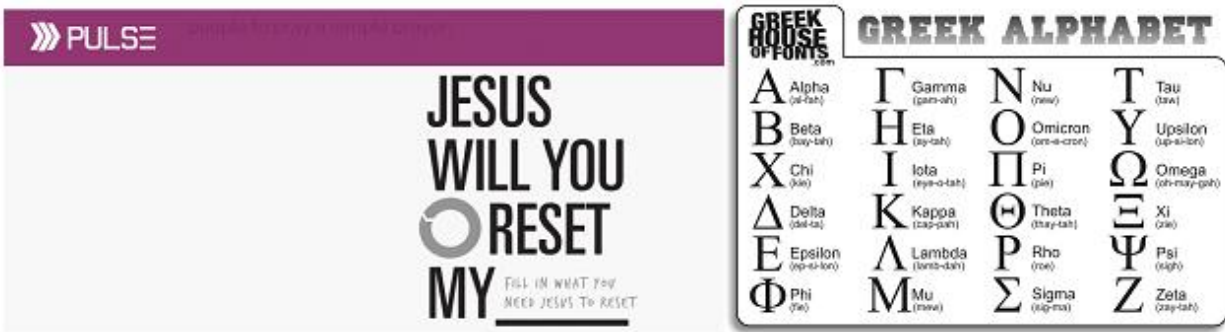
While people are occasionally seriously injured or killed by these weapons, fatalities are relatively infrequent. Causes of death from non-lethal weapons are varied and occasionally uncertain. Misplaced or ricocheting shots, pre-existing medical conditions, inadequate user training, repetitive applications and intentional misuse have been implicated in different cases where death has occurred.

Directed energy weapons are weapons that emit energy in an aimed direction without the means of a projectile. They are non-lethal and can immobilize people as well as machines (e.g. vehicles). *Many times their computers are burned out because of the weapons they are being hit with.*

Directed energy weapons include electromagnetic weapons, (including laser weapons) and microwave weapons, particle beam weapons, sonic weapons and plasma weapons.

In 2003, a US military review reported that the electromagnetic radiation produced by PEPs had been shown to cause pain and temporary paralysis in animal experiments. * They targeted Ms. Susan’s cat and killed her and I know they were also targeting Ms. Patty’s dog. Brenda B. shared that they targeted and killed her dog as well.*

Pulsed Energy Projectile or **PEP** is a technology of non-lethal directed energy weaponry currently under development by the U.S. military. It involves the emission of an invisible laser pulse which, upon contact with the target, ablates the surface and creates a small amount of exploding plasma. This produces a pressure wave that stuns the target and knocks them off their feet, and electromagnetic radiation that affects nerve cells causing a painful sensation. The technology can also be used as a lethal weapon, and indeed an early name was pulsed impulsive kill laser.



Things like this “Together 2016 event at the Washington Mall” and the false flag of the “Pulse Nightclub” shooting – all point to this weaponry. Their inside joke.
