

TARGETING – Part Nineteen: FALSIFIED MEDICAL RECORDS

I want to share a personal story that happened to me and my family. Kennedy was playing basketball at a local church but was having problems with her knees. The pediatrician wanted us to see a specialist. The specialist recommended physical therapy. We went for the evaluation and to get some basic exercises for strengthening. They entered her information into their computer and set up a schedule for physical therapy. Everything was fine on that visit. Or so we thought. The next visit Kennedy had a young man for a therapist. They were almost through with the circuit of exercises for that day when the therapist whispers to me asking if there is anything special he can do to help Kennedy understand him. I said, what? What did you say? He said it again and I said what are you talking about? He let me see her computerized chart. They had her flagged as **barriers to learning**: Chronic mental illness, ADD, and visual problems!! Upon seeing that I began to raise my voice. I said, she does not have any of that! Then the young man shushed me. I kept looking and they had so many things recorded incorrectly. I was so upset that I told this young man that I wasn't leaving there without a copy of what he had in his records. I quickly became a problem and I'm sure the file was flagged. He told me he had to call his supervisor to get permission to give me anything. Then he printed out a copy and made me sign off saying that she did not have those things.



You guys have seen Kennedy many times. She is a happy and healthy child of God.

Here is what all they had on her chart: **Current medical history:** Comorbidity, which I had to look up and see what that was. It is the simultaneous presence of two chronic diseases or conditions in a patient. WOW! ADD, Chronic mental illness, and a heart murmur. She has never had any of these things.

Past medical history: Allergic rhinitis; chronic mental illness; constipation; food allergy; GE reflux; murmur, substance abuse; unspecified deficiency anemia; unspecified delay in development, unspecified visual loss, UTI, Vesicoureteral reflux; or wheezing.

Behavior: Chronic mental illness, ADD

I had to send this to Kennedy's pediatrician because they are an extension of them. She has not been seen by anyone else. They called me back and said no, they don't have any of that stuff recorded on her chart and they don't know where that information came from. They are the same corporation and all the information is now computerized and online. I made Scott copy the recording from the nurse saying they don't have any of that in their records and she certainly doesn't have any of those things. Then it was a job to wrestle with the Physical Therapy branch to make them clean up their records. The next time we went back Kennedy had a different therapists. It was the initial lady that did the evaluation for physical therapy that we felt entered all that information in. She came over and said hello and acted as if all was wonderful in the world. I looked at her and thought you can't be serious. You messed up my kids chart and you have the nerve to act like this around us. I felt like they were letting me know that they can mess you up if they want to. I didn't say anything to her about it but the supervisor said he talked to her about it.



I wanted to share all of that to show you how easy it is for them just to put something on your medical records and if you never see their computer screen then you have no idea. They can access it from anywhere. That lady could have been under mind control and triggered to copy and paste something onto Kennedy's chart. They tried to say that she was listing all the things Kennedy doesn't have, trying to defend her. But you and I know that they only list things

Well once I figured out what all I was dealing with and had managed to adjust and was coping with the pain, I didn't want on the anti-depressants anymore. Well, you can't just say you want off of something. You have to fill out paperwork and pass their test. I saw then how easy it is to get yourself classified as this or that and get trapped in a label by the medical field. All of this is reported to the government. They also keep tabs on if you get your prescriptions filled or not and report to your doctor if you don't. You can be noncompliant and when they squeeze down on regulations if you are marked as a noncompliant patient then you may not get your medications or what have you. I also had a dr. get mad at me and tell me I was trying to kill myself because I was taking ibuprofen along with steroids. So I told her that none of the medicine she was giving me was good for me either. We had talked about coming off of a certain medication and I was saying I didn't think I could come down as fast as she was suggesting and she curtly said well patients have had to quit cold turkey when

their insurance doesn't approve their refills. And how about that? That is all it takes, is to get stuck in the insurance approval loop and if they don't do it soon enough or there is a problem then you just don't get that medication. They have their finger on the pharmacists, doctors and insurance companies. All reporting to them.
